*Each of the undersigned being duly aware of the risks and hazards inherent in entering upon said premises and/or participating in any boating or other activities on said premises or on said Lake, hereby elects voluntarily to enter upon said premises knowing its present condition and having had full and ample opportunity to inspect the premises. Each of the undersigned hereby voluntarily assumes all risks of loss, damage, or injury that may be sustained by any or each of the undersigned, or any property of any or each of the undersigned while in, on, or upon said premises or while using their personal property.*

*This release shall be binding upon the heirs, next of kin, executors, administrators and personal representatives of each of the undersigned. In signing the foregoing release, each of the undersigned hereby acknowledges and represents:*

- A. *That he/she has read the foregoing release, understands it and signs it voluntarily.*
- B. *That he/she is over eighteen (18) years of age and of sound mind.*
- C. *That he/she is signing this release on his/her behalf and on behalf and on behalf on any minors for whom the undersigned is the parent or legal guardian.*
